The hotel will accept bookings after February 17, 2018 based on availability, however due to the height of ski season, rooms may be sold out prior to this date. Please note that a deposit will be required at time of reservation. Staying within CUES' rooms block will help keep registration prices down.

A daily breakfast buffet in the Peaks Dining Room plus gratuity is included in the room rate. Breakfast is served daily from 6:30–10:30 a.m. only. No credits or refunds will be offered.
