# Where should I stay?

We are hosting our meeting at the country's first tri-branded Marriott hotel in Nashville! Our meeting will be hosted at the AC Hotel by Marriott, but you can book rooms in Springhill Suites, Residence Inn, and the AC Hotel by Marriott.

Please make your hotel reservation prior to Monday, August 31, 2020, by going online. CUES group rate is available beginning on September 16<sup>th</sup>, through three days after the seminar concludes, but the rate is not available prior to September 15<sup>th</sup>.

The hotel will accept reservations after August 31<sup>st</sup>, **based on availability**; however, rooms may be gone, or the rate will increase so early reservations are recommended. Staying within CUES' room block will help keep registration prices down.

\*Remember that all hotel arrangements are strictly between you and the hotel. In the event your flight is canceled, you are responsible for calling to cancel your room reservation.

Check-in time is 4:00 p.m. and check-out is at 12:00 p.m.

#### **Tax Exemption Information**

## Airport

The hotel is located approximately 8 miles (22 minutes) from the BNA Airport.

Uber and Lyft service are approximately \$25 each way to and from the airport.
