Tax Exemption Information

Airport

Embassy Suites by Hilton Chicago Downtown Magnificent Mile is located approximately 13 miles (30 minutes) from Chicago Midway International Airport or approximately 20 miles (60 minutes). These times are all dependent on daily traffic.

Transportation

Uber and Lyft services are approximately \$55 one way. When requesting services, please follow the directions below based upon your landing location terminal.

Chicago Transit Authority is an additional option for transportation. When leaving O'Hare, walk to the Blue Line 'L' Station and take the train until you reach the Grand stop. After Grand, you have the option to get on a public bus or you could catch an Uber or taxi to the hotel.

Air Travel
