There is a daily resort fee of \$20.00 per room, per night, which includes: internet access, business center computer access with printing and faxing capabilities, local phone calls, daily morning lobby newspapers, two in-room bottles of water on day of arrival, lobby coffee & afternoon beverage, in-room coffee, postcard mailing, and valet parking.

Make your hotel reservations prior to Monday, July 20, 2020, or by calling 855.342.4712 and reference "CUES Credit Union Executives Society" when making a reservation by phone.

Reservations made by telephone require a deposit equal to 40% of the estimated reservation value when the reservation is made, with the remaining balance due at 21 days prior to arrival. After a deposit is received, a confirmation will be sent.

Staying within CUES room block will help keep room rates down. Hotel arrangements are strictly between you and the hotel. The hotel will accept reservations after July 20 based on availability; however, rooms may be gone before then, so early reservations are recommended.

Check in is at 4:00 p.m. and check out is at 11:00 a.m.
