The CUES discounted rate at the Caesars Palace is \$164 for single or double occupancy. Please make your hotel reservations prior to Friday, November 11, 2022, by using this [booking link](#). If you prefer to phone in your reservation, you may call the Reservation Center at 866-227-5944 and mention CUES Directors Conference or group code SCCUE2 to get the contracted rate. **Be aware that a processing fee per reservation will be incurred if you choose to book a reservation over the phone.**

*\*Remember that all hotel arrangements are strictly between you and the hotel. You are responsible for contacting the hotel should you need to adjust or cancel your reservation.*

The hotel may accept reservations after November 11; however, availability and room rates are not guaranteed, so early reservations are recommended.

The rate is subject to applicable tax which is currently 13.8% per room, per night, and is subject to change without notice. This special rate is available for reservations beginning up to 3 days before the conference and 3 days after the conference, as room availability permits.

The daily resort fee is complimentary and includes:

- In-room internet access to include two (2) devices per room per day
- Unlimited local phone calls (no long distance or international calls)
- Two (2) guest admissions per day to the fitness center (does not include use of the spa)

Caesars Palace is located approximately 3 miles (10-12 minutes) from [Harry Reid International Airport](#), the primary commercial airport serving the Las Vegas major metropolitan area.
